Anthropologica is in its twenty first year of publication. Introducing the first issue Marcel Rioux its first director, wrote in 1955: "Anthropologica was conceived as an outlet for studies in cultural anthropology and linguistics which otherwise might not be published, due to the lack of specialized publications in Canada". The idea was well received and the new journal met with great enthusiasm both in Canada and abroad. The success of the first series as well as the felt need for a journal of general anthropology in Canada led to the publication of the new series in 1959. Anthropologica has since become an international journal of anthropology reflecting the developments, the crises, and the re-orientations of the sciences of man here and abroad in the past quarter of a century.

Anthropologica entre dans sa vingt et unième année de publication. Elle fut fondée en 1955 pour servir de débouché aux ethnographes canadiens dont certains travaux, faute de publications spécialisées, risquaient de ne pas être publiés. La revue fut accueillie avec enthousiasme au Canada et à l'étranger; bientôt il fallut songer à modifier la formule originale pour satisfaire à la demande. Aussi en 1959 la nouvelle série fut-elle lancée. Marcel Rioux, son premier directeur, écrivait à cette occasion: "...le besoin se fait de plus en plus sentir d'une revue qui publie des études d'anthropologie générale, d'une revue qui puisse être, au Canada, une espèce de carrefour des sciences de l'homme". Anthropologica est devenue par la suite une revue internationale d'anthropologie, carrefour des sciences de l'homme et témoin de leur développement pendant un quart de siècle.
